a. During office hours, Monday through Friday	N/C
b. After office hours or weekends	N/C
3. Shutting off and turning on water for non-payment:	
a. During office hours, Monday through Friday	\$25.00
b. After office hours or weekends	\$50.00
4. Additional charges, if necessary, to enforce payment of a bill and/or charges:	
a. Late fee assessed when an account is in arrears:	\$25.00
1. > \$75.00 and 60 days, or

b. Removal of a meter	\$25.00
c. Reinstallation of a meter	N/C
d. Installation or removal of a lock	N/C

7. Removal of a meter during construction (This is considered vandalism or illegal use of water)	Parts and labor plus 15%
8. A fire hydrant permit is mandatory for fire hydrant usage:	
a. Permit	\$35.00
b. Special usage (consumption only)	\$2.32/ccf
c. Unauthorized use	\$500.00
d. Using non-approved tank	\$500.00
9. New Service Deposit	\$50.00
10. New Service Administration Fee	\$25.00
